Amendments May 2, 2023

Section 2.1:

Motion to add: League Administration (Executive) shirts to be purchased for League Officers funded by the league as a uniform to be worn at all league representative functions. (Tina)

Section 2.3.6:

Director # 1 – responsibilities to run all Premier and 1st Division tournament. Helping with tournament prizes and assisting 1st Vice President with Banquet details. Will act as Sergent-of-arms at Special and AGM meetings. (Stacy)

Section 2.3.7:

Director # 2 – responsibilities to run 2nd & 3rd Division tournaments. Helping with tournament prizes and assisting with Banquet details. (Stacy)

Section 2.3.8:

Director #3 – responsibilities to run 4th & 5th Division tournaments. Helping with tournament prizes and assisting with Banquet details. (Stacy)

All Directors will assist where needed when asked by the President. (Stacy)

Section 3.2: Currently reads:

One copy of the Constitution and By-Laws (New teams only) or an Amendment Sheet will be included in each package. Additional copies may be printed from the website.

Motion to change wording to say: Rulebook and Amendment Sheet will be updated and available yearly on the LLDL website as a digital copy only. (Nancy & Jean "Go Green")

Section 3.9: Change date to add additional players the first Tuesday in December instead of First Tuesday in January. (Nancy)

Section 4.0 "League Rules" Currently reads:

All Divisional League play shall commence by 8:00pm. If a Team with a minimum of three (3) Players does not show up at the proper time, play commencement will be played no later than 8:15pm. If a Team with a minimum of three (3) Players has not shown up by 8:15pm, the points for the night may be claimed at the discretion of the offended Team (see Section 5.22 for scoring). If teams start before 8:00 pm then the grace period is null and void, and once play has started there is no stopping.

Motion to change play start time to 7:30 pm with grace period change to 7:45 pm. (Tina)

Section 5.18 a,b,c,d,e Add in: *Game formats are non-negotiable and will be voted upon by Executive members. (Tina)*

Section 5.19 a): Currently reads:

A wheelchair will be allowed to bring the large (rear) wheels) to oche line, providing the torso (upper body) is behind the line.

Motion to change wording to say "A wheelchair will be allowed to bring the front of the large rear wheel to the oche line.... (Tina)

Under Trophies and Awards:

Motion to change the current name of the "Cancer Tournament" to "Charity Tournament". (Tina)

OR change Cancer Tournament name to Ladies Memorial night, all money collected from draws and donations will go to charities. The winners of 1st and 2nd will receive a trophy at the banquet & no money received. (Tammy)

Motion to change the current name of the "President's Trophy" to "Memorial Tournament" (Tina)

OR Change President's Trophy to a Memorial Tournament. Every term (2 years) a new name will be voted on. Names can be submitted to the LLDL Secretary. (Stacy)

Mixed:

- 1. When a team wins their division they must move up to the next division and last place team must move down a division. (Tammy)
- 2. When you're requesting a division and your team splits up from previous year and you want to still play in that division you must have at least (three) 3 player that played in that division to qualify for that division. (Tammy)
- 3. Banquet Guest and Escorts must Pay the plate price of the venue that year. Reason the ladies league is always paying the difference. (Tammy)
- 4. To not start a round that can not be completed before the season ends. So, every team plays an equal amount of times against each other in their division. (Charlene Morley)
- 5. To put the voting for executive positions put back to their original way buy being nominated at the AGM. (Charlene Morley)
- 6. In 3rd Division The team tournament to be changed from two (2) games round Robin to one (1) game; as then we wouldn't be so late getting finished. (Tammy Collier, Dream Team)
- 7. In 2nd Division Double 1 rule by using all 3 darts after a certain period of time. (Denise Crozier Dart Kittens)
